Summary of key findings for parents

This provision is inadequate

- The provider does not ensure that staff implement the safeguarding policies and procedures effectively. Some staff have their mobile phones on them when dealing with children's personal care needs. In addition, the manager does not ensure that registers are accurately maintained. This significantly compromises children's welfare.
- Although staff take part in supervision sessions with management, these have failed to drive sufficient improvements in their knowledge and practice, and the quality of teaching is weak. Staff are not meeting all statutory requirements and these breaches compromise children's welfare and learning.
- Staff do not plan routines and activities, or organise resources, to meet all children's needs. Children cannot easily choose what they would like to use, and are expected to sit and listen for long periods, so opportunities to play and explore are limited. Staff plan for their key children's learning but do not always use these plans. Therefore, children are not helped to make good progress.
- The provider has not notified Ofsted of changes to the nursery's opening hours, and she does not have all the required records available and accessible for inspection.
- Systems to evaluate and monitor the provision are ineffective. The provider has a limited understanding of her role and responsibilities regarding management of the nursery. She has failed to address all actions raised at the last inspection or to identify areas of the provision that still require improvement. She still does not meet all the requirements of the Early Years Foundation Stage.

Inspection findings

Effectiveness of the leadership and management is inadequate

The management of the nursery is ineffective. The provider has failed to address all previously raised actions. The management team does not identify key areas of weakness in the organisation and delivery of the educational programmes. Children's attendance records are not accurately maintained and not all required documentation was available for inspection. For example, more children were in attendance on the day of inspection than were recorded in the register, and staff qualifications could not be verified as evidence was not on site. The provider identified that staff hold appropriate qualifications, and receive regular supervision. However, staff do not routinely use what they know to help promote children's learning. Management fails to effectively monitor how the educational programme is implemented to help drive improvements to staff practice and the quality of teaching. Consequently, children are not being helped to make good progress. Safeguarding is ineffective. The provider does not ensure that staff robustly follow the safeguarding procedures, and there are several breaches of safeguarding and welfare requirements. These breaches have a significant impact on the safety and wellbeing of children. Nonetheless, the provider uses appropriate systems to recruit and check staff suitability to ensure only those suitable to work with children do so. The provider welcomes all children and their families and makes sure that diversity is valued in the setting. Children learn to respect others to help prepare them for their future lives in the community.

Quality of teaching, learning and assessment is inadequate

The nursery manager and staff plan activities for children but these are not always matched to their individual needs. Parents talk to staff about their children and share ideas of what interests them at home. These ideas are included in planning but staff do not use them on a day-to-day basis to enthuse and motivate children in their learning. There is a variety of resources within the nursery. However, these are not all organised in a way that enables children to easily choose them for themselves, as many of them are in a large cupboard that only staff can enter. Therefore, children have insufficient opportunities to lead their own play and follow their own interests. Staff support children's developing language skills appropriately when they are working in small groups. For example, children listen to staff saying letter sounds, and practise their conversation skills with them as they play outside with dolls. Children practise counting aloud as part of group story times. Consequently, they become familiar with the names of numbers. Key persons make observations of their key children and plan ways of supporting them at nursery. However, these plans are not routinely followed, which prevents children from making the progress they are capable of.

Personal development, behaviour and welfare are inadequate

Children play together well. They enjoy riding bikes and scooters outside, which help them develop appropriate physical skills. Children behave well and follow instructions quickly and willingly. However, some staff expectations are unrealistic. For example, staff make children sit and wait for long periods unoccupied while they clear up the room. Children

develop positive relationships with the adults that care for them and are keen to be alongside them. Staff promote children's independence by giving them jobs to do, such as handing out plates and selecting their own fruit at snack time; this helps to build their confidence. Most children are developing some skills for their future learning. Staff help children to share and take turns, and offer them praise to build on their confidence and encourage them to attempt some tasks independently.

Outcomes for children are inadequate

Children are not making the best possible progress, given their starting points. Staff assess most children as having below expected levels of achievement and are failing to support them to improve what they can do. Children are not able to always choose for themselves what they would like to play with, or how they would like to build on their learning. Although staff make observations and assessments on what the children can do, they do not routinely use these or follow their key children's individual planning to precisely focus on helping children make the best possible progress in their learning. Therefore, although children are happy, they are not all developing the knowledge and skills they will need for their future learning.

Regal Brook Nursery registered in 2013. It operates from premises at the back of the Freedom Centre International Church in Welling, in the London Borough of Bexley. It is open each weekday, from 9am until 4pm, term time only. The nursery receives funding for the provision of free early education for children aged two, three and four years. The nursery employs five members of staff, of whom four have appropriate early years qualifications at level 3 and level 4.
