Summary of key findings for parents

The provision does not meet requirements

- The childminder does not have sufficient knowledge to promote children's learning effectively. This is because she is not fully aware of the learning and development requirements of the Early Years Foundation Stage. However, she does understand the importance of considering children's ages, skills and interest in order to meet their needs.
- The childminder is not aware that she must carry out the required progress check for two-year-old children, as part of the assessment requirements.
- The childminder's home is safe, warm and organised to ensure children can access what they need. She understands how to manage children's behaviour in a positive way.
- The childminder maintains a current paediatric first-aid certificate. This helps her to have up-to-date knowledge of how to meet the needs of children in the event of an accident.
- The arrangements for safeguarding are effective. The childminder has a thorough knowledge and understanding of all safeguarding practices. She has attended relevant training and is aware of how to detect possible signs or symptoms of abuse.
- The childminder describes how she will work with parents and share information about children's progress and daily activities, giving examples, such as working closely with parents to help their children settle and support their emotional well-being.
- The childminder understands how to promote children's physical well-being. She discusses the importance of providing children with a healthy diet and ensuring they have regular opportunities to be active outside in the fresh air.
- The childminder shows knowledge of how to promote children's understanding of keeping safe, for example, by talking to children about how to cross the road safely.
- The childminder reflects on her practice and action is taken to address any areas identified for improvement.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What the setting needs to do to improve further

To meet the requirements of the Early Years Foundation Stage the provider must:
