Summary of key findings for parents

The provision meets requirements

- The childminder demonstrates a sound understanding of the Early Years Foundation Stage requirements. This enables her to support children's development and promote their well-being. Safeguarding is effective. The childminder is aware of the procedures to follow should she have any concerns about a child's well-being, in order to safeguard children in her care.
- The childminder demonstrates an awareness of how to support children's learning and development through observational assessments. She knows to plan and provide learning experiences that promote children's progress well.
- The childminder understands the need to work in partnership with parents and engage with them to work closely together to support children's care and learning needs.
- The childminder has taken appropriate steps to act on actions and recommendations raised at her previous inspection. Therefore, she demonstrates a sound understanding of how to improve her knowledge and service offered to children.
- The childminder recognises her responsibility to be a positive role-model to children. This is to support children to develop an understanding of expected behaviour, develop respect for others, and form positive friendships with those around them.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector held discussions with the childminder to explore her understanding of the learning and development requirements, and the safeguarding and welfare requirements.
- The inspector looked at a sample of the documents that the childminder uses when childminding, and the policies and procedures she shares with parents.
- The inspector looked at areas of the home and outdoor spaces used for childminding.
- The inspector spoke to childminder about how she intends to develop her role further through self-evaluation and training.
