Summary of key findings for parents

The provision meets requirements

- The childminder has a secure knowledge of how to manage children's safety. He knows what to do if he has a concern about a child's welfare. His first-aid training is up to date and he knows what to do in the case of an emergency. He has organised his home to minimise any risks.
- The childminder has a good range of resources to promote children's learning across all areas. He has a sound understanding of the learning and development requirements, and knows how children learn and develop.
- The childminder is committed to self-evaluation, and reflects on how to improve his practice and the setting. He ensures that his training is up to date.
- The childminder understands the importance of keeping parents well informed about their child's learning and development.
- The childminder is committed to promoting healthy lifestyles for children, including going outside daily and eating healthy foods.
- The childminder understands how to promote good behaviour. He knows how to help children get ready for going to school by helping them develop skills, such as getting dressed independently.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector had a tour of the areas to be used for childminding, including inside and the outdoors.
- The inspector looked at the resources that the childminder intends to use.
- The inspector looked at the children's records that the childminder had previously prepared; and read through the policies and documents that the childminder intends to use.
