## Summary of key findings for parents

### The provision meets requirements

- The childminder provides a welcoming home for children to play in. She understands how to provide activities which meet children's individual needs.
- The childminder understands how to provide children with enjoyable, interesting and challenging experiences across the different areas of learning.
- The childminder understands the Early Years Foundation Stage requirements. She attends training courses to improve her knowledge of how children learn and develop.
- The childminder understands how to safeguard children, and ensures her household members' ongoing suitability. She understands her roles and responsibilities to protect children and keep them safe.
- Children have access to a wide range of toys and materials so they can choose them independently.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

### Inspection activities

- The inspector discussed with the childminder how she intends to provide experiences which meet children's needs.
- The inspector looked at documentation and policies the childminder uses when caring for children.
- The inspector looked at the written views and comments of parents.

The childminder registered in 2000. She lives with her four children in a house in the Gosport area of Hampshire. She holds a level 3 qualification in early years. There were no children on roll at the time of the inspection.
