Summary of key findings for parents

The provision does not meet requirements

- The childminder shows understanding of the requirements of the Early Years Foundation Stage and Childcare Register. However, she is not meeting all requirements relating to supporting children's well-being and safety.
- The childminder has failed to update her training to ensure she holds a current first-aid certificate as required. Therefore, she may not have the latest advice for dealing with children's injuries.
- The childminder has not ensured that all members of her household aged over 16 have completed the required Disclosure and Barring Service check. This means that not all members of the household's suitability to be in contact with children has been checked.
- The childminder has a clear understanding of the learning and development requirements. She has suitable processes for completing assessments of children's learning and for tracking their progress. The childminder described play activities and practical experiences to support children's learning to help them make progress ready for school.
- The childminder understands the importance of physical and outdoor play and a healthy diet for children to promote their good health and well-being.
- The childminder is clear about her role in supporting children to feel safe and secure and to help them feel included. She plans to offer flexible settling-in arrangements, consistent routines and positive guidance to support and promote children's awareness of managing their behaviour.
- The childminder has understanding of the importance of forming good partnerships with parents and professionals involved with children. She is aware of working closely with them to promote a consistent approach to meeting children's individual needs.
- The childminder shows understanding of the benefits of completing self-evaluation to help identify and support improvements to her practice and service.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What the setting needs to do to improve further

To meet the requirements of the Early Years Foundation Stage and the Childcare Register the provider must:
