Summary of key findings for parents

The provision meets requirements

- The manager demonstrates a good understanding of the safeguarding and welfare requirements. All required documentation is well organised and the manager has clear procedures in place to keep children safe and well.
- The manager and staff hold current paediatric first-aid certificates. They show a good understanding of how they will meet children's needs in the event of an accident or an emergency.
- The manager has a good knowledge and understanding of working with the other professionals. He explains how he will work closely with the staff at the host school and use the knowledge gained to complement care and learning in the setting.
- The manager understands the importance of evaluating what the setting does to support children's well-being and safety. Improvements are planned and the manager and staff have completed all the required training as part of their commitment to ongoing professional development.
- The provision has an extensive range of toys, resources and equipment to support children's play and learning. The manager ensures that these are safe and suitable for use.
- The manager demonstrates a good understanding of the action to be taken in the event of an allegation being made against a member of staff. Staff have a secure knowledge of safeguarding procedures which reflect the expectations of the Local Safeguarding Children Board.
- The manager demonstrates a secure understanding of the benefits of developing effective partnerships with parents, in order to learn as much as he can about children's individual needs.
- Staff have a good understanding of how to promote children's positive behaviour, tolerance and mutual respect of others.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector and the manager viewed the areas of the provision where childcare is to be provided.
- The inspector checked evidence of the suitability and training of the manager and the suitability of all staff who will be working with the children.
- The inspector looked at policies and other documents that the manager will use when caring for children.

Hollyfield Kids Club registered in 1998. The provision opens Monday to Friday for 51 weeks of the year. Sessions are from 7.30am until 9am and 3.20pm until 6.30pm. The provision employs four members of childcare staff, all of whom hold appropriate early years qualifications at level 3.
