Summary of key findings for parents

The provision meets requirements

- The childminder has a secure understanding of the requirements for the Early Years Foundation Stage. She is clear about her role in safeguarding children and knows the procedure to follow in the event of a child protection concern.
- The childminder provides a wide range of toys and resources to promote children's learning and development. She has a clear understanding of how to observe, assess and monitor children's progress and support their next steps in learning.
- The childminder has a clear understanding of how to work in partnership with parents, other early years providers and local schools to benefit children's care and learning.
- The childminder understands the importance of promoting children's well-being. She understands how to meet children's individual needs and ensure they settle well in her care.
- The childminder knows how to help children understand good behaviour. She explains how she helps them to consider the needs of others and respect each other during play.
- The childminder describes how she would promote the importance of a healthy lifestyle with children. This includes providing healthy snacks and encouraging physical development through a range of well-planned activities, both inside and outside the home.
- The childminder has a positive attitude towards driving improvement to strengthen her service and improve outcomes for children. She holds a relevant childcare qualification and demonstrates with confidence how she will promote children's learning and development.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
