Summary of key findings for parents

This provision is good

- The childminder has created a warm and welcoming environment. She provides a good selection of easily accessible and interesting resources, both indoors and outdoors.
- Children are very happy, secure and confident. They develop positive attachments to the childminder, who is very caring and attentive to their needs. This encourages children to play and explore their environment and supports their emotional well-being.
- Children are very well supported to develop their independence skills and manage their own personal care needs.
- Children's needs are effectively identified and well supported by the childminder. This helps children to make good progress in their learning from their starting points.
- The childminder respects children's opinions and ensures that they feel valued and listened to. This helps to build their confidence and self-esteem.
- The childminder develops very positive relationships with parents and they express high levels of satisfaction with the quality of their children's care. They receive regular feedback about their child's progress and about the activities that their child has participated in.

It is not yet outstanding because:

- The childminder sometimes misses opportunities to support children's understanding of what constitutes a healthy diet.
- Occasionally, some group activities do not fully maintain the interest of all children.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

- make better use of opportunities to support children's understanding of healthy lifestyle choices
- enhance the opportunities for all children to become deeply involved in activities.

Inspection activities

- The inspector observed activities and interactions between the childminder and children throughout the inspection.
- The inspector spoke with the childminder and children at appropriate times throughout the inspection.
- The inspector looked at children's assessment records and a selection of policies and procedures.
- The inspector viewed the areas used for childminding.
- The inspector looked at evidence of the suitability of the childminder and household members, and discussed her methods for self-evaluation.
- The inspector undertook a joint observation with the childminder.

Inspection findings

Effectiveness of the leadership and management is good

The well-qualified childminder demonstrates a good understanding of the learning and development requirements of the Early Years Foundation Stage. She observes and assesses each child, in order to highlight their achievements and monitor their learning and developmental needs. The childminder understands how the experiences she provides for children support all areas of learning. This helps children to gain the key skills to prepare them for school. Regular information sharing between parents and the childminder promotes a consistent approach to supporting children's ongoing learning and development. The arrangements for safeguarding are effective. The childminder's everyday practice reflects her strong commitment to protect children and support their own understanding of how to keep safe. She is also naturally reflective of her practice and actively seeks feedback from parents and children. The childminder is aware of her strengths and identifies areas for development to continue to improve her provision and knowledge.

Quality of teaching, learning and assessment is good

The childminder gathers information from parents about children's preferences, routines and abilities. This helps children to settle well and identify their starting points. The childminder has a good understanding of child development. She accurately assesses children's progress and plans for their next steps in learning. As she plays alongside children, the childminder skilfully asks questions, offers guidance, challenges and provides encouragement. This helps to extend children's speaking and listening skills and supports their ability to think critically. The childminder supports children to make good progress and prepares them for the next stage in their learning and development. Children are active and generally well motivated to play and explore. However, occasionally during group activities, the childminder does not always fully consider how children can be deeply involved in activities.

Personal development, behaviour and welfare are good

Children are happy and their needs are well met. They settle quickly and become confident in their new environment, as a result of a caring and well-informed induction phase. The childminder is a good role model. Through her calm and positive manner, she sensitively supports children to understand how to be kind to each other. This helps children develop good social skills and learn to respect each other. The childminder gives children every opportunity to be independent in their personal care and to develop good hygiene routines. Children enjoy opportunities to be active outdoors and are provided with healthy snack choices. However, the childminder occasionally misses opportunities to support children's understanding of the importance of developing healthy eating habits.

Outcomes for children are good

Children are well supported by the childminder to make good progress in their learning and are emotionally well prepared for the next stage in their learning.
