## Summary of key findings for parents

### The provision meets requirements

- The childminder understands how to promote children's development. She has a range of toys and resources to enhance children's play and learning.
- The childminder has assessments, monitoring and planning records in place to help her track and evaluate children's development. She has settling-in procedures to help her to build secure relationships with children and to help children to feel settled when they start.
- The childminder understands the signs and symptoms that would cause her concern about a child's well-being. She knows how to respond to concerns and follow guidance. She has procedures and risk assessments to ensure that the home is safe and secure.
- The childminder is aware of her role to support children's well-being. She understands how to maintain children's good health by providing nutritious snacks and meals. She understands how to promote and encourage children's positive behaviour to help children to feel secure.
- The childminder understands the importance of working in good partnership with parents and others involved in children's care. The childminder understands the need to ensure her training is up to date, and strives to improve and reflect on her practice.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children.
