# Summary of key findings for parents

#### This provision is inadequate

- There are significant weaknesses in the quality of teaching that hamper children's learning. Management does not effectively monitor the quality of staff practice or children's progress. Self-evaluation is ineffective at targeting improvements.
- Arrangements for the supervision of staff are not rigorous enough. As a result, management do not provide sufficient mentoring and coaching to support staff's professional development, skills and abilities to improve outcomes for children.
- Staff do not complete accurate observations and assessments of children's learning and development to identify children's individual learning needs. Therefore, teaching and planning to help children make suitable progress is not effective.
- Staff do not fully understand how to support children who are learning English as an additional language. This means that staff are not always able to support these children's individual needs well enough. In addition, staff do not support them in their learning to ensure they make good progress and are prepared for the next steps in their learning.
- Staff do not gather sufficient information from parents about children's starting points and learning needs. As a result, their knowledge and understanding of some children as individuals is limited and staff do not plan effectively for children's progress.
- The provider has not provided Ofsted with the required information about all new members of the committee, as a result the suitability of all members of the committee has not been verified.

#### It has the following strengths

■ Children develop some independence skills and enjoy spending time in the outside play area where they enjoy being physically active.

# What the setting needs to do to improve further

The provision is inadequate and Ofsted intends to take enforcement action We will issue a Welfare Requirements Notice requiring the provider to:

# Inspection findings

#### Effectiveness of the leadership and management is inadequate

The provider does not have a clear understanding about their responsibility to meet the requirements of the Early Years Foundation Stage and Childcare Register. They have failed to notify Ofsted of committee changes, which is a breach of requirements. Disclosure and Barring Service checks have been completed for some new committee members, but not all. As a result, Ofsted are unable to determine the suitability of committee members to be involved in the management of childcare. The provider has not addressed the action set at the previous inspection, although the manager has been working with the local authority to identify areas of further improvement. However, while weaknesses are identified, actions taken to tackle these are not effective. As a result, there is insufficient monitoring of children's progress and staff practice. This means staff do not receive adequate targeted support and supervision to improve their skills to support children. Staff have a secure knowledge of child protection and the action they would take if they had concerns about a child's welfare. Consequently, safequarding arrangements are effective.

### Quality of teaching, learning and assessment is inadequate

The quality of staff's teaching is inadequate. While most staff are well qualified and have understanding of how children learn, they do not extend children's learning. For example, when staff lead a story and song time, they do not include children's interests by introducing songs or stories of their choice. Consequently, children lack engagement and motivation, and quickly lose interest and move away. Staff do use some opportunities to develop children's communication and language skills; however, this is not consistent. For example, children who are learning English as an additional language do not make sufficient progress. Furthermore, staff do not gain enough information from parents about their children's stage of development on entry. Staff complete observations and assessments of children's learning regularly. However, these are not accurate and do not cover all areas of learning. As a result, children's individual learning needs are not well planned for.

#### Personal development, behaviour and welfare are inadequate

Most children play confidently and explore happily. However, staff do not always support children learning English as additional language sufficiently. As a result, these children lack skills to interact with other children. Furthermore, staff are not always able to communicate with them to understand their individual needs fully. Staff do not use strategies to support their individual learning and emotional needs well enough. As a result, these children tend to play by themselves and, therefore, are not fully included in activities to prepare them for the next stages in their learning. Children behave well, as staff are good role models. Staff talk to children about routines, which supports some children to develop their understanding of positive behaviours, such as sharing and turn taking.

# **Outcomes for children are inadequate**

Children do not make adequate progress, in particular those who are learning English as an additional language. Children's starting points are not established well enough for staff to monitor their progress over time. Children are not well prepared for the next stage in their learning or for school, as gaps in their progress are not identified and acted on.

Playhouse Pre School registered in 2000 and is run by a committee. It operates from Cove, near Farnborough in Hampshire. The pre-school is open Monday to Friday, from 8.45am to 11.45am during term time. It receives funding for the provision of free early education for children aged two, three and four years. There are four staff who work with the children. Of these, three hold relevant qualifications between level 3 and level 5.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register.
