The provision meets requirements

- The childminder has a clear understanding of the requirements of the Early Years Foundation Stage. She shows understanding of how children develop and the importance of working in partnership with parents and carers.
- The childminder has records in place to help her track, assess and monitor children's development. She has a suitable range of toys and resources to encourage play across the seven areas of learning.
- The childminder is aware of her role to maintain children's well-being. For example, she plans to offer healthy snacks and meals and regular outings for fresh air and exercise.
- The childminder understands how to promote and encourage children's positive behaviour, to help them learn to share and be tolerant of others.
- Safeguarding is effective. The childminder has a suitable awareness of her responsibility to protect children and is aware of the action to take in the event of a safeguarding concern.
- The childminder understands the need to ensure her training and documentation is current and to be reflective to help drive future improvements.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
