- The childminder understands the need to provide a range of furniture, equipment and toys that are safe, maintained in good condition and developmentally appropriate for children of differing ages, alibies and backgrounds.
- Safeguarding is effective. The childminder understands child protection issues and knows how to proceed if a child is at risk of harm. She understands how to promote children's health and well-being.
- The childminder understands the importance of working in partnership with parents and other providers to exchange information regularly about children to help meet children's needs.
- The childminder understands how to help children learn to behave responsibly. She knows how to plan activities according to children's needs to help them progress and prepare them for school.
- The childminder has addressed previous actions and recommendations. She understands the need to improve her childcare practice through self-evaluation and training.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
