- The childminder understands how to promote equality in her setting. She is aware of how to help children learn right from wrong while supporting their individual needs.
- The childminder has a range of appropriate toys and resources that offer challenge and support in all areas of development.
- The childminder understands her role in maintaining children's safety. She has safeguarding policies and procedures to refer to, and understands the importance of providing children with a safe and secure environment.
- The childminder understands the advantages of good communication with parents, and others involved in children's care, to promote continuity.
- The childminder is committed to improving her practice through training and uses selfevaluation to reflect on her practice.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children.
