Summary of key findings for parents

The provision meets requirements

- The childminder understands the importance of maintaining good relationships with the parents so that they can work together to provide consistent care for children.
- The childminder understands how to promote children's learning and development. She understands the need to plan activities to promote children's interests and their individual needs ready for future learning.
- The childminder understands how to provide a safe environment for children. She assesses her home to identify any risks and reduce any hazards for them while they play.
- The childminder manages her assistant well, provides children with appropriate equipment and ensures she maintains the required ratios.
- The childminder understands her responsibilities to safeguard children's welfare and the procedures to follow if she has any concerns.
- The childminder knows how to promote healthy lifestyles for children. She provides healthy meals and opportunities for children to spend ample time outside.
- The childminder understands the benefit of training, self-evaluation and gathering feedback from parents to develop her practice. She keeps detailed policies and procedures which parents can view on a daily basis.
- The childminder understands how to promote diversity and teach children to respect others. She also understands how to support children with special educational needs and those learning English as an additional language.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

- The inspector discussed with the childminder how she intends to deliver the educational programmes for children.
