Summary of key findings for parents

The provision meets requirements

- The childminder knows how to manage children's safety. She has safeguarding procedures and knows what to do if she has a concern about a child's welfare. Her first-aid training is up to date and she knows what to do in case of an emergency.
- The childminder has policies and procedures that she shares with parents during the settling-in period. She understands the importance of keeping parents well informed about their child's learning and development and how this benefits children.
- The childminder understands the learning and development requirements and knows how to promote children's learning to gain skills that prepare them for their next steps. The childminder understands how to support children with special educational needs.
- The childminder understands how to promote and celebrate diversity to help children learn how to respect each other and the wider community.
- The childminder knows how to support children's well-being by promoting healthy lifestyles. She plans outside activities for fresh air and exercise. The childminder promotes good behaviour by helping children understand how to manage their feelings.
- The childminder knows the importance of keeping her knowledge up to date. She works with other professionals and undertakes regular training courses to help maintain and improve her practice.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector checked the premises and resources that the childminder intends to use.
- The inspector viewed a range of documentation including suitability, policies, procedures, qualifications and training certificates.
- The inspector checked the childminder's knowledge of learning and development requirements, including how to complete progress checks for two year olds.
- The inspector discussed the childminder's plans for her provision.
