This provision is outstanding

- The superior quality of the childminder's teaching extends and inspires all aspects of children's learning and development. As a result, children are highly motivated and eager learners, who make consistently high rates of progress.
- The childminder creates an extremely strong sense of caring, belonging and community for children and their families.
- There are highly effective partnerships with parents and other professionals. Children's individual needs are quickly identified and exceptionally well met.
- Children's health, safety and emotional well-being are given the highest priority. Children are kept fully safe and are protected from harm.
- The childminder is an inspirational role model. Leading a local childminder's group she shares her expert knowledge and practice with other providers. She actively supports and develops local childminders' practice.

Inspection findings

Effectiveness of the leadership and management is outstanding

The childminder is well qualified and very experienced. She undertakes ongoing and well-targeted training and research. This results in her higher level of knowledge and understanding of statutory and other government requirements. She uses this superior level of knowledge to expertly tailor the best care and learning experiences for children. Arrangements for safeguarding are effective. Children are kept safe at all times. Comments from parents demonstrate the enormously positive contribution the childminder makes to the lives of children who attend. They note the numerous ways they are included in their children's learning and the high quality of information and guidance they receive. The childminder continues to build upon her already first-rate practice. For example, she has plans to develop her garden further to enhance children's outdoor play experiences.

Quality of teaching, learning and assessment is outstanding

Teaching is consistently of a very high standard, inspirational and worthy of dissemination. The childminder has an ingrained knowledge of what inspires children to learn and how she can help them. There is a remarkable variety of resources and children enjoy the freedom to make choices for themselves. They become independent learners. The childminder provides optimum levels of support for children to develop their communication and language skills. She is highly effective in fostering children's interest, particularly in books and storytelling. She continually challenges children to take the lead in their learning. She is playful, enthusiastic and shows children how to be inquisitive. Children confidently find things out for themselves through trial and error.

Personal development, behaviour and welfare are outstanding

Children are physically active throughout the day. They freely move their play from the indoors to outside. Younger children develop high levels of independence and confidence to explore their surroundings. They explore their own abilities and learn to manage risks and challenges safely. For example, they watch and then copy older children walking safely along a balancing beam. Children are expertly supported to learn how to express the range of feelings they are experiencing, including those of loss. They continually receive strong messages of equality, which helps them to value and respect others. For example, the childminder actively and sensitively challenges any stereotyping during children's play. There is an exceptional range of resources that positively promote diversity. Children learn to embrace and value differences through all aspects of their play.

Outcomes for children are outstanding

Children are exceptionally well prepared for school and make rapid progress from their starting points. They are continually finding new ways to do things and to solve problems during their play. Children enjoy taking part in conversations. They listen and follow instructions, take turns and share with other children. They express their thoughts, ask and answer questions and look at books to find things out. They know letters make sounds and they can recognise familiar words and write recognisable letters and numbers.
