Summary of key findings for parents

The provision meets requirements

- The manager has a good knowledge and understanding of safeguarding policies and practice intended to safeguard children. She has a good awareness of how to identify the signs and symptoms of abuse and the action to take if she has any concerns regarding children's welfare.
- The manager has systems in place to ensure a safe learning environment is maintained through effective use of risk assessments of the premises.
- The manager understands the need for regular self-evaluation of practice in the club to help identify areas for improvement. She discusses how she ensures that records and documents reflect current guidelines and that they are shared with parents.
- The manager understands the need for developing good relationships with parents to ensure there is a two-way flow of information which provides children with continuity and consistency of care. She works closely with parents and local schools to support children throughout their time at the club.
- The manager understands how to promote children's well-being and has a good understanding of how to foster children's attachments and relationships. She understands how to promote positive behaviour and develop children's self-esteem.
- The manager has a sound knowledge of how to provide a range of activities that is linked to children's interests and that complements their learning at school. She understands how this positively supports children to continue to develop their knowledge and skills.
- The manager confidently discusses how she promotes children's understanding of leading healthy lifestyles. She has a clear understanding of how to support children's physical development by offering them opportunities to explore and play outdoors.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector viewed the areas of the church premises where the club operates from.
- The inspector discussed with the manager her knowledge and understanding of the Early Years Foundation Stage requirements.
- The inspector checked evidence of the manager's suitability and qualifications, and discussed the self-evaluation process for improving practice.
- The inspector looked at documentation, records and a selection of policies and procedures that the manager will use when caring for children.

Church on the Way Kidzone operates from the Church on the Way, Idle, Bradford. The holiday club is open Monday to Friday for two weeks of the summer holidays, opening hours are from 8.30am until 4pm. The manager is a qualified teacher.
