Summary of key findings for parents

The provision meets requirements

- The childminder has an appropriate understanding of promoting children's well-being, such as supporting their good health, behaviour and inclusion. She is aware of safeguarding procedures.
- The childminder knows how to promote children's learning and development through observational assessment, and how to provide appropriate learning experiences to enable children to make progress.
- The childminder has met recommendations raised at the previous inspection. This has brought about improvements in gaining relevant information about children's development when they start, and for addressing self-evaluation regularly.
- The childminder understands her responsibility to work in partnership with parents and any other professionals involved in the children's care and education, in order to meet the children's needs.
- The childminder reflects on her training needs and has attended relevant training since the last inspection. She welcomes the regular support of the local authority, and involves parents in the self-evaluation process to gain regular feedback.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector discussed with the childminder how she supports children's ongoing development, and how she engages parents to be involved.
- The inspector sampled documentation, including the records to safeguard children and promote their welfare.
- The inspector sampled children's learning records which included a range of observational assessments.
- The inspector observed all areas of the premises used for childminding and the resources for children's play and care.
- The inspector reviewed the childminder's systems for self-evaluation, including steps taken since the last inspection to develop her practice further.
