Summary of key findings for parents

This provision is outstanding

- The childminder provides opportunities for children to learn through activities that thoroughly absorb their interest. She uses her expert skills and knowledge to help children enjoy learning through play and make outstanding progress.
- The childminder provides exceptionally well-resourced and comfortable play areas. Children of all ages can safely choose what to play with from the extensive range of toys and materials.
- Children have extremely warm, close relationships with the childminder. As a result, they settle quickly and develop extraordinary self-assurance.
- The childminder provides a very wide range of opportunities for all children to be confident learners. She encourages them fully to follow their own ideas to play and explore.
- The childminder uses training to develop her skills to a high level. This means she meets children's individual needs exceptionally well.
- The childminder gathers extensive information about children when they first attend. She continues to share information with parents, which keeps them fully up to date with children's progress.
- The childminder evaluates and reflects thoroughly on her work with the children. She monitors their progress rigorously to ensure she maintains her drive for improvement.

Inspection findings

Effectiveness of the leadership and management is outstanding

The childminder has an exceptionally secure understanding of how to meet the Early Years Foundation Stage requirements. She has completed an early years qualification to improve even further her knowledge of how children learn. She has developed excellent and comprehensive methods for monitoring children's learning and development and the effectiveness of her practice. This means she is constantly identifying areas for development and taking effective action to improve her practice. Safeguarding is effective. The childminder has a thorough understanding of the most recent safeguarding procedures to follow to protect children from harm.

Quality of teaching, learning and assessment is outstanding

The childminder uses excellent teaching methods to promote children's learning and development through many exciting activities. For example, during the inspection, children were clearly delighted as they used large spoons and tongs to pick up conkers they had collected on a nature walk and post them in a toy with differently sized tubes and funnels. As they played, children's physical development and language skills were effectively challenged and extended as they described what they were doing and how the conkers felt. Through daily activities, children learn about different sizes and shapes to support their early mathematical skills. Children enjoy learning about their own families but do not always extend their understanding of people in the wider community.

Personal development, behaviour and welfare are outstanding

The childminder very carefully supports children to learn how to manage their own safety, such as taking particular care when using large play equipment. She is scrupulous when teaching children about the importance of good hygiene routines. The childminder works closely with parents to ensure children have thoroughly healthy and well-balanced meals and snacks. Children have excellent opportunities for outdoor play. They wear appropriate clothing to be out in all weathers so even the youngest children play and explore in the garden. The childminder's high quality care means that all children very quickly gain the necessary skills for the next stage in their learning.

Outcomes for children are outstanding

All children make significant progress from their individual starting points in all areas of their learning. The childminder uses her knowledge of children's needs to make effective plans to swiftly close any gaps in their learning and development. Children rapidly gain the skills they need for moving on to pre-school or school.
