Summary of key findings for parents

This provision is outstanding

- The childminder works in highly effective partnerships with parents and other professionals to ensure continuity of learning and care for children.
- The childminder is a positive role model for children and has strong behaviour management skills. Children listen to the childminder, are well behaved and display extremely good manners.
- The childminder provides excellent opportunities for children to achieve. This boosts children's self-esteem; they are confident and learn to take risks appropriate to their age and ability.
- Children are acutely aware of their feelings and emotions, and the childminder discusses this with them very effectively during play activities.
- The childminder has an excellent commitment to maintaining and driving improvements in her practice and her own professional development. She attends a variety of relevant courses and uses the information gained to provide stimulating learning experiences for children.
- The childminder skilfully supports and promotes children's language and communication by encouraging them to talk exceptionally well. Children are inquisitive and enjoy asking questions. They make outstanding progress.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

increase opportunities for children to explore and practise using a range of technology in aspects of their daily lives.

- The inspector observed the children during their play activities, as well as their snack routine.

Inspection findings

Effectiveness of the leadership and management is outstanding

Safeguarding is effective. The childminder has an excellent knowledge of safeguarding and how to keep children safe. She is aware of the procedure to follow should she have any concerns about a child's well-being. The childminder accurately and effectively evaluates the service she provides. She actively seeks the views and opinions of parents and she acknowledges fully children's enjoyment of activities. She uses this information very effectively to make the necessary changes and improvements to her practice. As a result, the childminder provides a consistently high quality service. The childminder strongly values equality and diversity. She provides a wide range of opportunities for children to explore and understand people and cultures different to their own.

Quality of teaching, learning and assessment is outstanding

The childminder expertly promotes children's learning and development by skilfully questioning them. She holds very high expectations of children and supports them effectively to achieve challenges suitable to their age and ability. As a result, children gain in confidence due to their achievements. Overall, the childminder has an excellent knowledge of how to promote and incorporate learning in all play activities, although opportunities for children to explore a range of technology are not fully developed. Children are excited and eager to participate in learning experiences that are fun and exciting. The childminder plans effectively for each child's needs. She monitors their progress consistently and her assessments are clear and accurate; these show that children make excellent progress. The childminder has an excellent knowledge of each child and how to move them on in their learning. Children independently choose from an exceptional range of resources that are used to promote learning, in an environment that is safe and stimulating.

Personal development, behaviour and welfare are outstanding

The childminder is highly skilled in helping children to form secure emotional attachments. Children are very happy and settled in her care; they share a lovely relationship with the childminder. The childminder consistently praises and encourages children to promote their confidence and independence. Children feel safe and at ease, and happily explore their environment. Children have excellent listening skills; they follow the childminder's instructions and are exceptionally well-behaved. Children understand the importance of following a good hygiene routine and eating healthy food. They benefit from fresh air and exercise during outdoor activities.

Outcomes for children are outstanding

Children are exceptionally well prepared for their move to school or other early years settings. The childminder provides stimulating activities that develop their mathematical and literacy skills. Children are confident because the childminder praises and encourages them at all times. Children make consistently high rates of progress.
