## This provision is outstanding

- The childminder is highly effective in liaising with professionals to support children moving on to schools and nurseries. This supports extensively the continuity of children's care and learning

- Children are extremely happy, motivated and engaged in the very welcoming environment provided by the childminder.
- Children have access to an excellent range of toys and resources. They are able to make independent choices in their play and continually extend their own learning.
- The childminder monitors her provision and children's development very accurately, to ensure children continue to make exceptional progress.
- The childminder is a very positive role model for children. She reinforces excellent behaviour through lots of praise and encouragement, which gives children the confidence to persevere and take on new challenges. Children gain an exceptional understanding of managing their own behaviour.
- The childminder has an excellent relationship with parents who are fully involved in their children's learning.

# **Inspection findings**

## Effectiveness of the leadership and management is outstanding

The childminder has an exceptional awareness of protecting children and risk assessing the environment. She has a very secure knowledge of safeguarding and has up-to-date information on the procedures to follow if she is concerned about a child. Safeguarding is effective. The childminder is highly motivated and exceptionally committed to the improvement of her setting. She continuously updates her already excellent knowledge and skills. For example, she accesses a wide range of training courses, researches information and regularly meets with other professionals to share her high quality practice.

## Quality of teaching, learning and assessment is outstanding

The childminder's quality of teaching is outstanding. She has a relevant childcare qualification and uses her excellent knowledge to provide high-quality learning experiences that inspire and capture children's interests. She provides challenging activities with the right level of difficulty to enable all children to join in and learn. Overall, children's literacy skills are very well developed. For example, they quickly learn that words carry meaning while enjoying looking at books and listening to their favourite story. Older children have fewer opportunities to develop further their early writing skills to strengthen their interest in literacy. The childminder is extremely skilful in providing high quality communication and interactions. For example, she congratulates them for using descriptive words, when they talk about the 'crunch' sound the cereal makes. The childminder provides many inspiring activities, which stimulate children's imaginative and expressive ideas.

#### Personal development, behaviour and welfare are outstanding

The childminder provides rich learning opportunities and motivates the children to develop their independence. For example, the children use knives safely to help prepare fruit for snacks. All children are busy and extremely happy in the childminder's care. They demonstrate they feel very safe in the environment as they explore, knowing that the childminder is close by for a reassuring cuddle. The childminder provides the children with daily opportunities to go out in the fresh air. She takes children on regular trips to places, such as groups, parks and woodlands. They develop a good knowledge of their local community. Children make excellent progress in developing their personal and social skills as they take turns and share resources with friends.

## **Outcomes for children are outstanding**

Children make tremendous progress. They are extremely confident and eager to explore their immediate environment. This prepares them extremely well for the next stage in their learning, development and first steps to school.
