Summary of key findings for parents

This provision is good

- The childminder has a good understanding of safeguarding procedures and provides a safe environment for children.
- Children form close relationships with the childminder. Children settle easily and are happy in her care. This supports their emotional well-being.
- The childminder observes and assesses children's progress effectively. She organises a good range of activities that reflect children's interests.
- Children make good progress in relation to their starting points. The childminder is successful at developing children's skills ready for the next stage in their learning. She shares children's progress regularly with parents and works with them to plan for children's next steps.
- The childminder understands the importance of working with other professionals to seek further support and guidance to support children.
- Children learn about leading healthy lifestyles because the childminder discusses why they should eat fruits and vegetables rather than sweet foods. She ensures that they have daily opportunities to play outside in the fresh air to develop their physical skills and well-being.

It is not yet outstanding because:

- The childminder does not always make the most of daily routines and play activities to discuss and extend further children's understanding of safe practice.
- Sometimes, the childminder misses opportunities to further develop children's thinking and problem-solving skills as they play.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

- strengthen children's understanding of safe practices during play and daily routines
- extend the use of opportunities which arise during the day to develop children's thinking and problem-solving skills.

Inspection activities

- The inspector observed activities and the quality of teaching.
- The inspector sampled a selection of policies and relevant documentation.
- The inspector spoke to the childminder and children at appropriate times during the inspection.
- The inspector sampled children's learning documents and assessments.
- The inspector took account of the views of parents by reading parents' testimonies.

Inspection findings

Effectiveness of the leadership and management is good

The childminder displays a good commitment to ensuring children receive good care and education. She shows a clear understanding of the requirements of the Early Years Foundation Stage. Safeguarding is effective. The childminder has a good understanding of the changes in legislation and the procedures to follow to ensure children's welfare and safety. The childminder uses self-evaluation effectively to assess her practice. She attends training to develop her knowledge and understanding. For example, observation and assessment training has helped to improve how she monitors children's progress. The childminder is keen to undertake a level 3 qualification as she is aware of the positive impact this will have on children's development and her own practices.

Quality of teaching, learning and assessment is good

The quality of teaching is good. The childminder provides children with a wide range of interesting and stimulating play experiences. Children are enthusiastic about their learning because the childminder encourages them to be creative and use their imaginative skills. For example, the childminder plays alongside children as they play with toy cars and trains. She talks about what is happening and models relevant sounds, such as the fire engine siren, to extend their interest and enjoyment. The childminder effectively supports early literacy skills and mathematical development. For example, she shares stories with the children and they help her to prepare lunch. Parents praise the childminder for her professional manner and stimulating environment. The childminder listens to children's questions and supports their developing language skills. This helps children to express their thoughts and ideas and ask for help when they need it.

Personal development, behaviour and welfare are good

The childminder has a good knowledge of children's individual personal needs, likes, dislikes and interests. This helps to develop children's sense of belonging and confidence. The children enjoy playing with the childminder and sharing experiences. The childminder attends a local childminding group to provide the opportunity for children to develop social skills and confidence. The childminder encourages children to be independent and to think of their friends as they play. Therefore, children learn to behave, share and take turns well. This helps to support children's emotional well-being. The celebration of different festivals provides children with opportunities to learn about other people and different communities. Therefore, children learn to value and respect other cultures and differences between themselves and others.

Outcomes for children are good

Children make good progress in relation to their starting points and learn at their own pace. Children preparing for moving to school are learning to be independent, for example, getting themselves ready to go outside, self-care skills, development of early writing skills and recognising the sounds letters make. This helps children to confidently move into school.
