- The provider has a good understanding of the safeguarding policy and procedures. She knows to ensure all staff have an in-depth understanding of how to identify any welfare concerns a child may have and how to report these promptly.
- The provider knows to ensure children have opportunities to learn about diversity and that they learn about good behaviour.
- The provider understands her role in providing staff with opportunities to undertake further training to develop their professional practice. Furthermore, she has met the actions and recommendations from the previous inspection.
- The provider knows to ensure staff hold paediatric first-aid certificates to promote children's welfare. She understands the importance of maintaining records of children's details and a written complaints procedure.
- The provider understands the importance of assigning a key person to individual children to promote their well-being.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

- The inspector discussed with the provider her understanding of the safeguarding and welfare, and learning and development requirements.
- The inspector looked at the areas of the provision available for children.

Gidea Park School Club registered in 2010. The club is situated in Gidea Park in the London Borough of Havering. The breakfast club operates Monday to Friday, from 7.50am to 8.50am, and the after-school club operates from 3.20pm to 5.50pm. The club is open during term time only. The provider employs four staff. Three staff, including management, hold early years qualifications at level 2 or above. There were no children in the early years age range present at the time of the inspection.
