- The childminder keeps her first-aid training up to date. This means she knows how to respond to accidents and emergencies.
- The childminder understands the importance of a healthy lifestyle for children and the promotion of this through fresh air, exercise and a healthy diet.
- The childminder knows how to reflect on and monitor her practice and provision. She attends some training to help keep her knowledge relevant to the service she offers.
- The childminder understands the importance of developing an effective partnership with parents in order to meet the needs of the children.
- The childminder understands the importance of maintaining records with relevant details of any children she cares for.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children.
