Summary of key findings for parents

The provision meets requirements

- The childminder has a good knowledge and understanding of the learning and development requirements. She demonstrates how she will plan stimulating and challenges experiences for children to engage their interests.
- The childminder carefully considers how she will support children's individual needs, cultures and beliefs through observation and assessment.
- The childminder has a clear understanding of safeguarding practice. She knows how to recognise potential concerns about the welfare of children and the procedures to follow to help to ensure all children are safe from harm.
- The childminder understands the importance of effective partnerships with parents to enable her to meet children's emotional well-being.
- The childminder is aware of how to support children to develop good manners and kindness to each other and to respect each other.
- The childminder knows how to recognise and encourage children's independence whilst at play and at meal times. This helps children to gain self-care skills in readiness for the next stage in their learning.
- The childminder demonstrates how she will make ongoing improvements. For example, she reflects on her practice, the environment and the resources on offer to improve the learning and development opportunities for the children in her care. She also regularly attends training to keep her knowledge up to date.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector took a tour of the premises and viewed the resources with the childminder.
- The inspector checked evidence of the childminders qualifications and suitability of all adults in the home.
- The inspector sampled a range of documentation, including policies and procedures and fire evacuation procedures.
- The inspector discussed self-evaluation with the childminder.
