Summary of key findings for parents

This provision is good

- Children form secure and nurturing relationships with the childminder. She knows children very well and is attentive to their individual needs. Children are settled, happy and display good levels of confidence and self-esteem.
- The childminder organises a broad range of well-planned activities for children in her home and in the outdoors. Children are motivated, eager to learn and make good progress in their learning.
- Children are supported to lead a healthy lifestyle and be physically active. For example, they enjoy many different walks and visits in the local community, go swimming and attend music and movement classes.
- The childminder demonstrates a commitment to continuous improvement. She regularly seeks the views of children and parents and effectively prioritises improvements that will benefit children and their families the most.

It is not yet outstanding because:

- The childminder does not always give children enough time to be able to think through and answer more-complex questions.
- The childminder does not consistently ask parents to share information about children's learning when they first attend.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

- provide even more time for children to be able to think through and answer morecomplex questions
- gather more consistently the views of parents about their children's learning when they first begin at the setting.

Inspection activities

- The inspector observed the quality of teaching during activities indoors and outdoors, and assessed the impact this has on children's learning.
- The inspector checked evidence of the suitability of household members, self-evaluation and documents that support the childminding service.
- The inspector spoke to the childminder and the children at appropriate times throughout the inspection.
- The inspector completed a joint observation with the childminder and discussed this with her.
- The inspector looked at children's assessment records and planning documentation.
- The inspector took into account the views of parents in the form of quality questionnaires and feedback sheets.

Inspection findings

Effectiveness of the leadership and management is good

The arrangements for safeguarding are effective. The childminder has attended training and has a good knowledge of her role and responsibilities to protect children and keep them safe. Her home is secure, she has conducted risk assessments and she holds a valid first-aid certificate. The childminder makes good use of conversations and daily diaries to keep parents well informed of their children's learning and care. She gathers good information about children's individual needs, abilities and preferences. However, she does not yet maximise opportunities for parents to contribute to initial assessments, when children first start in her care. The childminder actively undertakes regular continued professional development. She has accessed many courses to complement her, already good, knowledge. She uses information gained from this to effectively enhance her provision.

Quality of teaching, learning and assessment is good

The childminder uses her good knowledge to observe children and to make accurate assessments of their individual stage of development. She promotes their learning and development well, through play and planned activities. Children are confident communicators. The childminder asks children lots of questions as they play and provides a good narrative. This helps children to extend their vocabulary and understanding. However, the childminder does not always allow children sufficient time to answer morecomplex questions. Children develop their small-muscle skills well. For example, they use their fingers and hands to feel, mix and spread paint. Children have good imaginations and show motivation for learning. They talk to the childminder about the texture and colour of the mixture and contribute their own ideas. Children develop good mathematical skills. They are encouraged to count in everyday routines and the childminder discusses concepts with children, such as shape and size. The childminder interacts positively with children and encourages them to make independent choices as they play.

Personal development, behaviour and welfare are good

Settling-in sessions are used well to ensure there is a smooth move from home to the setting. Children confidently explore the bright, well-resourced learning environment. Their good health and physical well-being are effectively promoted. Children enjoy healthy and nutritious meals and snacks and have plenty of outdoor activities. Children demonstrate their good independence skills when they select and chop their own fruit at snack time and wash and dry their own hands. The childminder is a good role model. She encourages children to be polite and use good manners. She uses age-appropriate strategies to manage behaviour and children behave well, given their age and stage of development.

Outcomes for children are good

The quality of teaching practice and delivery of education programmes is constantly under review. The childminder undertakes regular and accurate observations of children. Planning reflects the individual needs of children and appropriate next steps are in place to extend learning. Children make consistently good progress and are well prepared for the next stage in their learning and school.
