Summary of key findings for parents

The provision meets requirements

- The childminder understands the requirements of the Early Years Foundations Stage. She knows how to keep children safe and provide learning experiences to meet children's different needs.
- The childminder knows how to develop effective partnerships with parents. She knows to obtain all information about their child from the parents and build professional relationships. She understands the importance of sharing children's achievements and development to support their learning and well-being.
- The recommendation set at the last inspection relating to learning and development have been met. The childminder has an improved understanding of how to use assessments to observe, assess and plan for children's next stages in learning.
- The childminder understands the importance of promoting children's awareness of diversity. She knows how to manage children's behaviour and teaches them to respect other cultures, share and make decisions together.
- The childminder understands safeguarding procedures, including how to identify any concerns and report these to the relevant agencies to help safeguard children.
- The childminder holds a first-aid certificate, which equips her with the skills needed to deal with any accidents and injuries children may have.
- The childminder understands the importance of self-evaluation methods to identify and target priorities for improvement.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector held discussions with the childminder about her role and responsibilities in meeting the requirements of the Early Years Foundation Stage.
- The inspector viewed the areas of the premises that are available to children.
- The inspector discussed the policies and procedures the childminder will use.
- The inspector discussed the safeguarding and welfare requirements with the childminder.
- The inspector reviewed relevant documentation, and discussed the childminder's methods for improving her provision.
