# **Summary of key findings for parents**

## This provision is good

- Children feel secure in the care of highly sensitive and nurturing staff. They make sure they get to know children extremely well, building their confidence and helping them to enjoy learning.
- Children play with a range of activities and resources in a well-presented and warm environment. Staff plan activities well, such as those that reflect children's preferred styles of play, which help children become highly engaged.
- There are many strategies in place that support children to understand the natural world and their place in it. Staff have developed the outdoor play space exceptionally well and offer children plenty of fresh air and exercise.
- Parents have a good level of involvement in their children's learning. Staff find out about children's learning at home, and work with parents and other professionals involved in children's learning to ensure continuity.
- Leaders make good use of government funding they receive to promote children's development and to help them gain the essentials skills needed for later learning.

#### It is not yet outstanding because:

- Occasionally, staff do not always use daily activities to challenge older children in order to help them find their own ways to represent and develop their ideas.
- Leaders do not always make the best use of monitoring systems to help them improve the good standards of teaching even further, particularly to identify ways to help older children make more rapid progress.

# What the setting needs to do to improve further

## To further improve the quality of the early years provision the provider should:

- increase the challenges presented to older children to help them find their own ways to represent and develop their ideas to extend their learning further
- improve monitoring processes to help raise the already good quality of teaching, particularly to support older children to make more rapid progress.

## **Inspection activities**

- The inspector took account of the views of parents.
- The inspector spoke with staff, children and parents at appropriate times throughout the inspection.
- The inspector conducted a joint observation with the deputy manager.
- The inspector sampled a range of documentation, including the setting's policies, procedures and children's records.
- The inspector observed children's daily play activities.

# **Inspection findings**

## Effectiveness of the leadership and management is good

Leaders are highly skilled and embed daily procedures that reflect the needs of the children; they ensure the safety of staff and children is paramount. Safeguarding is effective. Staff have a secure understanding of local child protection procedures. They have a good level of knowledge to help them identify possible signs that may raise cause for concern. Leaders set high expectations for children's behaviour and embed a positive approach to managing any challenges. Self-evaluation processes are effective. They reflect the views of parents and other professionals in order to help identify ways to drive forward improvement. Leaders implement effective systems for staff supervision, including professional development opportunities such as further training to update staff knowledge and skills.

# Quality of teaching, learning and assessment is good

Staff plan activities for children based on a secure system of assessment. For example, they work with parents from the very start to establish children's developmental levels and to identify what they need to do in order to extend children's learning. Children get a great deal of support from staff to develop and become ready for school. Children develop good communication and language skills through activities that build a foundation for early literacy. For example, staff use signing and picture books when singing with babies, who respond by giving eye contact and copying their gestures, showing a clear level of understanding for their age.

### Personal development, behaviour and welfare are outstanding

Children make outstanding progress in their personal development and behaviour. Staff place children's welfare at the centre of everything they do. Staff are highly skilled in ensuring children develop strong emotional attachments. Strategies are securely in place to help those children who need extra support to feel confident and safe in their care. Overall, children develop a positive sense of themselves, and gain strong personal, social and emotional skills. There is a great emphasis on the importance of physical play and staying healthy. Staff have high standards of care for the children. For example, they keep nappy changing facilities and milk preparation areas exceptionally clean and tidy. Children develop an awareness of their own and others' achievements. For example, staff encourage them to recognise and celebrate other children's artwork and creations, which are on display for all to see.

# **Outcomes for children are good**

Outcomes for children are good. They make effective progress in their learning and development. They are acquiring the necessary skills to help prepare them for their future learning.
