### Summary of key findings for parents

#### The provision meets requirements

- Staff have a clear understanding of their roles and responsibilities with regard to child protection. They understand the possible signs of abuse and they know what to do if they have a concern about a child in their care.
- Staff undertake suitable risk assessments. They take suitable steps to minimise hazards to children, on the premises and during outings.
- Staff offer a welcoming environment. They know how to provide the children with activities that complement their learning elsewhere. Good quality resources are plentiful and stored in ways that children can easily access. Resources are obtained to reflect children's interests and abilities and to help them to respect and value diversity.
- Staff know how to promote children's well-being. They know how to manage children's behaviour positively. They provide daily opportunities for fresh air and exercise. They plan activities to help children to understand the importance of healthy eating.
- Staff obtain information from parents to support the children's individual care and learning needs throughout their time at the club.
- There are robust arrangements for staff recruitment and vetting. Staff receive ongoing training, coaching and supervision to support them in promoting children's enjoyment and safety.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

#### **Inspection activities**

- The inspector had a tour of the premises and viewed all areas that are used when caring for children.
- The inspector discussed with staff how they support play and learning when children are present.
- The inspector looked at policies, procedures and documents the provider uses when children are present.
- The inspector checked evidence of the suitability and qualifications of the staff, and looked at self-evaluation and improvement plans.

Galton Village Playcentre opened in 2003. It is run by Sandwell Adventure Play Association. It employs two members of childcare staff. Both hold appropriate early years qualifications at level 3. The centre is open from Monday to Friday, 3pm until 6pm and a holiday club runs from 12 noon to 6pm during school holidays.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register.
