Summary of key findings for parents

This provision is good

- Staff plan interesting play experiences, carefully considering children's differing needs and interests. Children are happy and engage enthusiastically in activities.
- Children enjoy a range of experiences outside. They improve their physical skills, and gets lots of fresh air and exercise.
- Children are consistently calm and well behaved. They treat each other kindly and with respect. Children help each other and develop positive values and attitudes. This helps to prepares them for the next stage in their learning as they move through school.
- The manager evaluates the quality of staff practice and the provision on offer. Staff benefit from an effective system of induction and appraisal. Ongoing professional development improves staff expertise. The club's service constantly develops to reflect the needs of children and their families.
- The manager has developed strong relationships with the feeder school and parents. Children benefit from a joined-up approach of effective information sharing.

It is not yet outstanding because:

- At times, the balance of activities in the main playroom makes it difficult for some children to concentrate on quieter pastimes.
- Children sometimes struggle to find a suitable and comfortable place to sit while they eat their snack.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

- review the organisation of activities in the main playroom to consistently promote children's engagement on their chosen activities
- continue to improve the area provided for snack time so that children can sit comfortably while they eat in a suitable place.

- The inspector observed children and staff inside and outside.
- The inspector conducted a joint observation with the manager.
- The inspector looked at a sample of documentation.
- The inspector spoke with parents and took their opinions into account.
- The inspector held a leadership and management meeting with the manager.

Inspection findings

Effectiveness of the leadership and management is good

Safeguarding is effective. Staff have a good understanding of child protection issues and the procedures to follow should they have any concerns. Staff are well deployed to promote children's safety and welfare. Staff take part in appraisals and performance management meetings. These identify training needs that effectively drive improvement forward. Staff and management provide a warm and welcoming environment to support children's overall development. Staff and management take inspiration from children's play to plan successful activities that motivate and interest children.

Quality of teaching, learning and assessment is good

Staff's interactions with children are of a good standard. The manager and his team work together to provide interesting experiences for children. For example, children explore balls of ice and decorate them with leaves and sticks. Children stay on task for long periods and work well together as they solve simple problems. For example, children build a fort with 'bricks' and spend considerable time decorating it with toy soldiers. Staff collect lots of evidence of children's achievements and share these with parents and school staff who feed them into their systems of assessment. This helps to promote continuity for children. Children enjoy playing outside; for example, they use an attractive garden and staff take them on visits to the local park. Children improve their physical skills, for example as they play team games with balls and hoops. Children play together harmoniously, developing their social skills and sharing their ideas.

Personal development, behaviour and welfare are good

Children are happy and settled as they play. Staff treat children with understanding; for example, they listen carefully when children speak. Children's ideas are valued. For example, children decorated ice-filled balloons and made them into 'ice babies', and staff enthusiastically helped children with their designs. Staff promote healthy lifestyles; for example, children have permanent access to the garden and get lots of fresh air and exercise, even in winter weather. Children enjoy a range of healthy food options at snack time. Staff provide children with opportunities to make choices and develop their independence. For example, children choose the things they would like to eat and make their own sandwiches. Children benefit from an embedded key-person system that helps them feel valued, happy and confident. The youngest children are well considered and have their emotional needs met. Parents state that they are very satisfied with the club and feel that staff keep them well informed.
