## Summary of key findings for parents

## The provision meets requirements

- The childminder understands the Early Years Foundation Stage requirements. She understands child protection procedures and knows how to safeguard the children in her care. She has attended training to update her knowledge.
- The childminder understands how to plan and provide a suitable environment and resources to meet children's individual needs. She knows how to observe and assess children's progress and how to use this information to plan for their next steps in learning.
- The childminder understands the need to keep children safe and to manage their behaviour appropriately. She knows the importance of undertaking effective risk assessments to minimise any hazards and promote children's safety.
- The childminder understands how to promote children's physical well-being, including the importance of teaching children about how they can develop a healthy lifestyle.
- The childminder understands the need to develop strong partnerships with parents and others who are involved in children's care and learning. She knows that it is important to share information to provide continuity of care.
- The childminder recognises the importance of regularly evaluating her provision and using this information to take action to improve the quality of her practice.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
