Summary of key findings for parents

The provision meets requirements

- The childminder knows the safeguarding requirements, including child protection procedures, and understands her responsibility to protect the welfare of children and to keep them safe.
- The childminder is aware of the need to observe and assess children's learning and has appropriate systems to undertake specific progress checks.
- The childminder recognises how to help children learn about expectations for behaviour, and how to support them to develop a respect for others.
- The childminder understands the importance of working in partnership with parents and other professionals in order to meet children's needs, and support children to move on to other settings, with confidence.
- The childminder implements a range of policies and procedures to safeguard children, and support children's health. She is aware of the importance of providing an environment that promotes children's well-being and physical safety.
- The childminder is aware of the relevance of self-evaluation to promote better outcomes for children and develop her knowledge further. She has addressed previous recommendations well from her last inspection.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector held discussions with the childminder to explore her understanding of the learning and development requirements, and the safeguarding and welfare requirements.
- The inspector looked at a sample of required records maintained by the childminder to monitor children's development, and the range of policies and procedures she shares with parents.
- The inspector spoke to the childminder about how she develops her role and knowledge further through self-evaluation and training.
- The inspector looked at play materials, equipment and areas of the childminder's home used for childminding purposes.
