### Summary of key findings for parents

#### The provision meets requirements

- The manager and deputy have undertaken safeguarding training. They have a good knowledge of the signs and symptoms of abuse, and they know what to do if they have any concerns about children.
- The areas for improvement identified at the last inspection have been addressed. The manager has ensured that safeguarding and paediatric first-aid certificates are in place. The manager understands the importance of reflecting on and improving her own practice and that of her staff.
- The manager and deputy both hold an appropriate early years qualification at level 3 which has given them a good knowledge of how children learn and develop. The manager undertakes regular training and arranges professional development for the staff to support continuous improvement.
- There is a suitable range of toys and equipment which children freely choose from, keeping them stimulated and interested in their play.
- The manager understands the importance of working in partnership with teachers so she can create a consistent approach to meeting the needs of children.
- The manager describes the value she places on the partnership with parents. She recognises their influential role and the importance of gathering and sharing information.
- The manager understands how to support the emotional needs of children. She describes the importance of building good relationships with children so they feel happy in the club.
- The manager and deputy know how to take into account children's individual needs and interests, in order to plan a wide range of activities for all children.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

#### **Inspection activities**

- The inspector looked at relevant documentation, such as policies and procedures and evidence for the suitability of staff working in the club.
- The inspector spoke to the manager and staff at appropriate times during the inspection.
- The inspector and manager toured the areas of the premises where childcare is provided.
- The inspector discussed the manager's methods of self-evaluation and how she plans to promote improvements to the club.
