Summary of key findings for parents

The provision meets requirements

- The provider has met the actions and implemented the recommendations made at the last inspection. This has resulted in more equipment and improved hygiene during snack time, closer links with the school and parents, and increased contributions from parents and children to the evaluation of the provision.
- The provider and staff demonstrate a secure understanding of how to provide planned, purposeful play experiences, which take account of the individual learning needs of young children, complementing their learning at school.
- The provider and staff understand how to promote children's behaviour in a consistent and positive way. They show an awareness of how to help children build positive relationships with others, make choices and be independent.
- The provider ensures young children have access to a well-organised play and learning environment. Children have access to a wide variety of resources and equipment, both inside and outside.
- The provider and her staff understand their responsibility to protect the welfare of the children in their care and have knowledge of how to safeguard children.
- Parents of older children who attend the club report that they are pleased with the service provided and the information shared with them by club staff. They state that their children enjoy their time at the club and are happy with the range of activities available. They comment that their children benefit from warm relationships formed with a reliable and stable staff team.
- The provider has systems in place to promote children's safety. For example, she ensures that all staff receive a thorough induction and follow safety policies and procedures. Parents are informed of procedures that are in place to keep their children safe. For example, they know the system to follow if another person is collecting their child.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector had a tour of the premises and viewed all areas that are used when caring for children.
- The inspector discussed with the provider how she supports children's play and learning.
- The inspector checked evidence of the suitability and qualifications of the staff, and talked with the provider about her self-evaluation and development plans.
- The inspector looked at policies, procedures and documents the provider uses when caring for children.
- The inspector took account of parents' views provided in written questionnaires. The inspector took account of the views of older children's parents who were spoken to during the inspection.
- The inspector spoke to members of staff and with older children who attend the provision.

Carr Lane Kids Club registered in 2010. The club is based within the grounds of Willerby Carr Lane Primary School, in the East Riding of Yorkshire. The setting cares for children who attend the host school and operates from 8am until 8.50am, and from 3.30pm until 6pm, Monday to Friday, during term time. The club is also open from 8am until 5.45pm, Monday to Friday, during some school holidays. There are eight members of staff. Of these, one holds an appropriate level 6 qualification and three hold an appropriate level 3 qualification.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the Early Years Foundation Stage.
