Summary of key findings for parents

The provision meets requirements

- The manager and staff team understand their role to safeguard and protect children in their care. They are aware of issues relating to child protection, including how to report any welfare concerns.
- All staff understand the importance of maintaining relationships with parents, including teachers from the school. They share regular information about children's progress in order to promote continuity.
- The manager knows how to monitor staff performance and to use the self-evaluation process to identify and improve the provision, including children's overall experiences.
- Staff and leaders are aware of how to help children learn new skills; they follow children's interests and needs.
- The manager is aware of the need for children to have access to age-appropriate resources, including both inside and outdoors.
- Staff know how to promote positive behaviour. They model and teach children how to behave towards others and show respect.
- The manager understands the importance of completing regular health and safety checks. She ensures the environment is safe for the children to play and explore.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector held discussions with the manager, including on how he intends to meet the needs of the different groups of children.
- The inspector looked at the setting's policies and documents, which the manager intends to use when caring for children.
- The inspector discussed with the manager processes for self-evaluation and the setting's improvement plan.
- The inspector toured the areas intended for children to use and viewed resources.

Surrey Square After School Club registered in 2007. It operates from the Surrey Square Junior School, in Walworth, in the London Borough of Southwark. It is open each weekday from 8am to 9am, and 3pm to 6pm during term time. During school holidays, the setting operates from 8am to 6pm. The provider employs four members of staff; three are qualified at level 3 and one is unqualified. There were no children in the early years age group present at the time of the inspection.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the Early Years Foundation Stage.
