- The childminder understands how to promote children's health and well-being. She talks about providing children with healthy meals and snacks, and daily opportunities for fresh air and exercise.
- The childminder knows how to manage children's behaviour positively. She understands her role in developing children's awareness of the needs and feelings of others.
- The childminder understands the importance of evaluating her practice and accessing regular training to improve her skills.

There were no children present when this inspection took place.
