Summary of key findings for parents

The provision does not meet requirements

- The childminder meets the safeguarding and welfare requirements of the Early Years Foundation Stage. However, the childminder does not have written procedures for safeguarding and complaints. These are breaches of the Childcare register.
- The childminder does not meet the learning and development requirements of the Early Years Foundation Stage. She lacks secure knowledge of how to observe and assess children's progress to help them be ready for the next stage of learning, and of the assessment check on their progress when children are aged two years.
- The childminder understands the importance of working with parents and with other professionals to help meet children's physical needs.
- The childminder understands the importance of managing children's behaviour in a positive way and of the need to teach them to respect others.
- The childminder understands the need to provide resources appropriate to the ages and abilities of the children attending.
- The childminder understands the importance of maintaining children's good health and well-being.
- The childminder does not evaluate her provision to help her drive improvement.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What the setting needs to do to improve further
