Summary of key findings for parents

The provision meets requirements

- The childminder knows how to use assessments to monitor children's progress and identify their developmental needs. She knows how to support children's development to ensure they are ready for future learning.
- The childminder values the importance of partnerships with parents and other settings that children attend, and realises their importance in children's development.
- The childminder knows how to adapt practice to support children with special educational needs.
- The childminder understands how to teach children to be healthy. This includes offering children healthy foods and regular opportunities for exercise and fresh air.
- The childminder uses the views of others, including parents and children, to evaluate her practice and make changes to benefit children.
- The childminder understands procedures for safeguarding children; for example, how to inform parents about any accidents.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector checked evidence of the childminder's qualifications and suitability for the position.
- The inspector looked at policies and documents the childminder uses.
- The inspector inspected the facilities and discussed with the childminder how she would use the space when children are present.
- The inspector discussed how the childminder meets the needs of children in her care.

The childminder registered in 2011. She lives in Crawley, West Sussex. The childminder opens five days a week, all day. There were no early years children on roll at the time of inspection. The childminder provides before- and after-school care.
