- The childminder knows how to protect children from harm and neglect. She understands the procedures to follow if she has any concerns about their welfare.
- The childminder knows how to keep children safe by completing daily checks of her house, to identify and reduce any hazards.
- The childminder understands the importance of outdoor play and exercise for promoting children's good health and well-being. She understands how to promote children's independence and good hygiene routines.
- The childminder is aware of the importance of managing children's behaviour appropriately. She understands the need to teach children to be polite, respect each other's feelings and manage their own behaviour.
- The childminder has a clear understanding of the importance of working in partnership with parents and others involved in the children's care, to promote continuity in children's care and learning.
- The childminder is aware of the need to evaluate and undertake training to improve her practice. She understands the need to supervise her assistants and update them on current childcare practices to strengthen their knowledge and skills further.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
