The provision meets requirements

- The childminder understands the learning and development requirements of the Early Years Foundation Stage. She knows how to assess children's progress and plans for their next steps in their learning.
- The childminder is aware of the importance of keeping herself informed of new developments. She continually updates her skills and knowledge to promote the learning of children of all ages and abilities.
- The childminder understands the importance of building positive partnerships with parents and other providers involved in children's care.
- An awareness of self-evaluation processes enables the childminder to understand the importance of reflecting on her provision to help drive continuous improvements.
- Using her understanding of how to promote children's healthy lifestyles, the childminder is aware of the need to provide children with healthy meals, establish hygiene practices, and ensure children have daily exercise and fresh air.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
