Summary of key findings for parents

This provision is outstanding

- Children make outstanding progress, thrive in all aspects of their learning and have lots of fun. This is a result of stimulating, challenging and well-planned activities that respond to children's interests.
- The childminder has an excellent understanding of the Early Years Foundation Stage requirements and how young children learn. She monitors children's progress thoroughly to ensure that any gaps in learning are closing and children make rapid progress.
- The childminder demonstrates exceptional commitment towards achieving excellence in all areas. She monitors the service she provides very effectively and works closely with her assistants and parents to make changes that have a very positive impact on children.
- The childminder engages children in conversation and is highly skilled at using questions to encourage children to develop their thinking skills to the highest level.
- The childminder works extremely well in partnership with parents, which is very effective in supporting children's learning at home. She values the importance of a continuous approach to children's care and actively seeks relationships with other early years settings that they attend.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

 explore ways to support younger children in becoming more confident to join in group activities.

- The inspector observed the quality of teaching during activities indoors and outdoors, and assessed the impact this has on children's learning.
- The inspector completed an evaluation of an activity with the childminder.
- The inspector looked at relevant documentation, including the childminder's selfevaluation and evidence of the suitability of adults that live in the household.
- The inspector took into account the views of parents during the inspection and spoke to the childminder and children at convenient times.
- The inspector completed a joint observation with the childminder.

Inspection findings

Effectiveness of the leadership and management is outstanding

The childminder is extremely conscientious and strives to create an excellent provision for children and their families. She has a thorough understanding of her role and responsibility to keep children safe from harm and ensures that her assistants are equally knowledgeable. Safeguarding is effective. The childminder ensures that her assistants are fully supported and have the high level of skills needed to enhance children's learning experiences. Parents express their full confidence in the childminder and her assistants. The childminder has created a culture which highly values and celebrates diversity. Children learn about differences and similarities in ways that are meaningful to them and prepares them exceptionally well for their future experiences.

Quality of teaching, learning and assessment is outstanding

The childminder and her assistants carry out regular, incisive observations and assessments of children's learning and development, taking into account parents' contributions. They support children's early mathematical and literacy skills exceptionally well and planned activities take into account children's next steps and interests. This has a very positive impact on children's progress and children are deeply engaged in their learning. Children have excellent opportunities to explore, investigate and make new discoveries during play. The childminder promotes knowledge and understanding of the world very skilfully and children enjoy a range of high quality learning experiences. They display great curiosity during their play and are inquisitive learners.

Personal development, behaviour and welfare are outstanding

Children are highly valued and respected as unique individuals. Children enjoy warm, nurturing relationships with the childminder and her assistants, who create an emotionally supportive setting in which children thrive. Adults have high expectations and children's behaviour is excellent. Children learn how to share, take turns and begin to understand and respect the views and needs of others. Children are provided with healthy meals and snacks and are supported to try new food and begin to make healthy lifestyle choices. The childminder is meticulous in completing checks of all areas to help ensure that these are safe for children as they play. She extends opportunities for children to develop their independence skills, which develops their self-esteem, although some younger children are not always supported as well to join in group activities.

Outcomes for children are outstanding

All children make good or excellent progress due to consistently expert teaching. Children are working at or exceeding the levels expected for their ages. Children's communication skills develop exceptionally well and they are extremely well prepared with the knowledge and skills needed for the next stage of their learning, such as starting school.
