Summary of key findings for parents

This provision is good

- The childminder provides children with a wide range of exciting and purposeful learning experiences. Teaching is very good and the childminder builds on children's learning effectively. Children make very good progress from their starting points and are well prepared for the next stage in their learning.
- Parents are involved in supporting children's learning and development. The childminder exchanges information with parents each day. She guides them in their support of children's progress and there is consistency and continuity.
- The childminder uses her observations of children to plan very well-focused activities. She obtains detailed information from parents and from her own assessments and establishes clear starting points for children's learning.
- Children's behaviour is very good. The childminder manages this very effectively and teaches them to have good manners. Children are very happy and secure and their needs are very well met. The childminder works closely with parents to meet children's care and learning needs and provides a very happy, family environment.
- The childminder monitors and evaluates her provision well and strives for continuous improvement. She works effectively in partnership with other local early years providers and maintains her good quality provision and improves children's learning experiences.

It is not yet outstanding because:

■ The childminder has not fully considered how best to ensure that her professional development contributes towards raising the quality of the provision to the highest standard.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

make even better use of professional development and increase the potential to achieve excellent outcomes for children.

- The inspector spoke to the childminder and children at appropriate times during the inspection.
- The inspector jointly observed and discussed with the childminder the teaching and learning activities provided.

Inspection findings

Effectiveness of the leadership and management is good

The arrangements for safeguarding are effective. The childminder implements rigorous safeguarding policies and practice and she supervises children vigilantly. The childminder is very well motivated and committed to providing high-quality care and learning for children. She reflects on her teaching and planning each week and adapts this to meet the learning needs of all children. The views of parents are actively sought and they report very positively on the childminder's provision. The childminder shares information about children's progress very effectively with the other settings that children attend. She complements their learning and protects their well-being. The childminder's wide experience has a very positive impact on children's learning opportunities.

Quality of teaching, learning and assessment is good

The childminder has a thorough understanding of how children learn through play. They enjoy an excellent range of activities and learning experiences. The childminder takes children on many outings to the beach, local parks, farms and woods. Children learn about the seasons and explore the natural world at first hand. Two- and three-year-old children play very well together and are imaginative in the role-play kitchen. The childminder challenges them very well during an activity which develops their small-muscle skills. Children manipulate large tweezers, chopsticks and other tools to pick up small pom-poms and dry pasta. They transfer them to different coloured bowls, count them and sort them into groups of the same object. Children explore what happens if they blow the pom-poms and polystyrene balls through straws, or suck to hold them on the end of the straw. The childminder makes all children's learning great fun and encourages them to persevere if they don't succeed immediately. Children count how many of each item it takes to fill different sized containers. This helps them to learn mathematical concepts well.

Personal development, behaviour and welfare are good

Children form close bonds with the childminder and enjoy playing and socialising together. The childminder teaches them to be kind to each other and to have good manners. She teaches children to share and take turns and to develop good social skills. The childminder praises children frequently and they gain confidence and good self-esteem. Children learn about healthy lifestyles and they enjoy a selection of fruit at snack time. They help the childminder to wash the blueberries and cut their own fruit safely. The childminder helps children to count their grapes and takes many opportunities to create learning experiences through the daily routines. Children enjoy being active outdoors each day and they develop their physical skills very well. The childminder prepares children very well emotionally for their moves to nursery and school.

Outcomes for children are good

Children are beginning to develop early literacy and mathematical skills effectively. They make consistently good progress from their starting points and are very well prepared for starting school.
