Summary of key findings for parents

This provision is good

- All staff get to know all children very well and form good attachments. The knowledge that key persons have about their key children enables individualised learning and good outcomes.
- The manager keeps up to date with current guidance and early years practice, and shares this effectively with all staff.
- Staff are very aware of how to minimise risks for children and help them to thrive in a safe environment.
- The manager encourages very effective relationships with parents. For example, she supports children's contact with parents who work away from home so they can share their experiences with each other.
- The staff promote children's learning about people and communities around the world. For example, they encourage parents to share information and resources to help children value people's differences and learn about the wider world.

It is not yet outstanding because:

The staff do not make the most of opportunities and learning experiences to help children make excellent sense of their physical world and the community in which they live.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

improve children's understanding of the world they live in.

Inspection activities

- The inspector toured the inside and outside of the setting, observing the quality of resources and teaching, and the impact these have on children's learning.
- The inspector sampled relevant documentation used.
- The inspector held discussions with the manager and the provider.
- The inspector carried out a joint observation with the manager.
- The inspector had some discussions with parents to gather their views about the setting and their children's experiences.

Inspection findings

Effectiveness of the leadership and management is good

The quality of the pre-school is constantly improved through the use of effective self-evaluation. The manager takes account of the views of parents and children to implement a positive development plan. Children are well-prepared for their move to school. Staff improve their knowledge and understanding through good support and training from the management team. Management and staff have a secure knowledge of the child protection procedures to follow if they have concerns. Safeguarding is effective. Management and staff monitor children's progress and development effectively. This helps them quickly identify and support any learning needs for individuals or groups of children so they continue to make good progress.

Quality of teaching, learning and assessment is good

Children are keen to take part in activities. For example, children play at the water table in the garden and swish the 'whales' and 'sharks' around the glittery water. Children have good language skills and talk to each other as they become absorbed in their play. For example, they say, 'I like to play with the sharks and swim them around and around; look he is shiny and very, very big'. Children enjoy art activities, such as painting indoors. They are imaginative and creative with mixing the colours. They clearly enjoy themselves, for example, as they laugh and giggle together as they talk about their paintings. Staff understand well how children learn and plan suitably challenging experiences. Children experience a broad range of activities, supported by a variety of resources that stimulate and challenge them

Personal development, behaviour and welfare are good

Children are attentive and listen to the staff and each other. They respond positively to instructions and behave well. Staff are good role models and effectively use positive language when with children. They consistently meet children's care needs well and children feel safe and secure, which supports their emotional well-being. Staff encourage children's independence in their own care needs. For example, children help to cut up fruit for snack time and pour their milk into mugs. Staff make the most of snack time; for instance, they sit with children and promote their communication and social skills. Children learn about the need to value and respect people's differences. They understand about the need for healthy lifestyles, for example, as they play outdoors in the fresh air.

Outcomes for children are good

All children make good progress in their learning, including those whose starting points are below that of other children of their age. Children enjoy playing and learning through wellplanned activities.
