## Summary of key findings for parents

#### This provision is inadequate

- The arrangements for safeguarding are inadequate. The provider does not have robust systems in place to ensure the suitability of staff. Staff are not aware of the circumstances in which they may be disqualified from working with children.
- The minimum qualification requirements are not met, nor are the required adult-tochild ratios. Children's attendance is not recorded accurately. This means children are not cared for by enough suitably experienced staff to promote their safety and wellbeing.
- Children do not benefit from having a regular key person. Staff turnover is high. The nursery relies heavily on casual workers and agency staff, which does not meet children's needs, especially those of babies and younger children. Children's care and learning needs are often not known by the available staff as communication during staff absences is poor.
- Teaching is weak. Planned activities do not match individual children's learning needs. Staff do not make regular observations and assessments of children's learning and development to ensure that all children make good progress.
- Staff do not receive effective supervision, training and coaching to help improve their performance. Cover staff and agency workers are not provided with enough information so that they can fully support the children in the setting.

#### It has the following strengths

Children are developing independence as they manage personal tasks, such as washing their hands before meals.

- The inspector held a meeting with the nursery manager and registered provider. She looked at relevant documentation, such as the nursery's self-evaluation and checked evidence of the suitability of staff working in the nursery.

# **Inspection findings**

#### Effectiveness of the leadership and management is inadequate

The arrangements for safeguarding are inadeguate. Managers do not make checks regarding staff's previous employment as part of a robust recruitment procedure. This puts children at risk of harm. They do not ensure staff are clear about their roles and responsibilities to safeguard children. Not all staff know when to report a change in their circumstances which may affect their suitability to work with children. However, staff know the signs of abuse and when and where to refer any concerns they may have. The qualifications held by the baby room staff do not meet legal requirements. Managers do not ensure that there is sufficient staff to meet the required staff ratios. Records of children's attendance are not accurate, particularly when children move rooms during the day. This compromises their safety in the event of an emergency. Managers do not review staff performance and the quality of their teaching. Managers do not train, coach or provide support to staff. They do not ensure staff are equipped with the skills they need to provide quality learning and development experiences for children. Managers do not provide opportunities for staff to discuss children's development or well-being. Consequently, disabled children and those who have special educational needs, in particular, do not receive the support they require. Parents report that they receive information daily regarding the activities their child has enjoyed. They appreciate the ideas they receive to continue their child's learning at home.

#### Quality of teaching, learning and assessment is inadequate

Support for disabled children and those who have special educational needs is inadequate. Staff do not take action to close gaps in their learning and development. Conversation is limited in the two-year-olds' room which prevents the development of good communication and language skills. Observation and assessment of children's learning in this room is also poor. Children's starting points are not established, which prevents children's progress being checked over time. Planning is broad and is not linked to children's individual next stage of learning. Activities are not tailored to meet children's individual learning needs. In the absence of the key person, cover staff and agency staff do not have sufficient information to effectively meet children's learning needs. This means they fulfil a supervisory role rather than providing quality learning experiences. Staff in the pre-school room provide a broad range of activities based on children's individual interests. However, leaders do not support staff to seek additional support where gaps in children's learning are identified.

#### Personal development, behaviour and welfare are inadequate

An exceptionally high staff turnover means there is a lack of continuity of care which does not promote children's emotional well-being. This results in babies and younger children becoming unsettled and upset. Weak recruitment procedures, inaccurate records of attendance and a failure to maintain the required adult-to-child ratios puts children at risk of harm. Children enjoy healthy snacks and meals. They benefit and learn about the importance of daily exercise and the impact it has on their bodies. Children's behaviour is good. Children practise fire drills regularly.

#### **Outcomes for children are inadequate**

Children do not make good progress. They are ill-equipped for the move on to school. Gaps in learning are not identified quickly enough, and action is not taken swiftly enough to prevent these gaps from widening.

First Steps Oldbury was registered in 2014. The nursery employs five members of childcare staff. All hold appropriate early years qualifications at level 2 to level 5. The nursery opens from Monday to Friday all year round. Sessions are from 7.30am until 6pm. The nursery provides funded early education for two-, three- and four-year-old children.
