# Summary of key findings for parents

## This provision is good

- The childminder shares purposeful and accurate information about children's learning with parents, the school and the local pre-school. This helps to consolidate children's knowledge and skills and prepares them well for future learning.
- The childminder is a good role model. She praises children's achievements and models positive behaviour. Children are learning to share, take turns and to consider and respect the needs of others.
- The childminder takes children to visit different groups, meeting with familiar friends and adults. She involves the children in local traditions, such as making decorations for the village Christmas tree. This supports children's social skills and confidence, and teaches them about their place in the community.
- The childminder strives to improve her practice. She sets targets that she successfully works towards. She actively seeks the views of parents. The childminder attends training and shares good practice with other childminders to further extend her skills and knowledge.

#### It is not yet outstanding because:

- Information about children's development is not used to consistently focus on how to raise children's progress to outstanding levels.
- The childminder occasionally misses opportunities to help younger children develop their mathematical skills.

# What the setting needs to do to improve further

# To further improve the quality of the early years provision the provider should:

- make the most of what is known about individual children so that specific areas of development can be targeted for rapid progress
- use every opportunity to develop younger children's early skills in counting and recognising numbers.

## **Inspection activities**

- The inspector observed the quality of teaching during activities and assessed the impact this has on children's learning.
- The inspector spoke with the childminder at appropriate times throughout the inspection.
- The inspector completed a joint observation with the childminder and discussed the teaching and learning with her.
- The inspector checked evidence of the suitability of all household members, children's records, policies and procedures, and recent training that the childminder has attended.
- The inspector viewed parents' questionnaires and written comments about the service and took account of their views.

# **Inspection findings**

## Effectiveness of the leadership and management is good

The arrangements for safeguarding are effective. The childminder has a sound understanding of what to do if she has any concerns about a child. She ensures that she is up to date with any new childcare legislation. The training the childminder attends is selected to improve the care, learning and development needs of the children. The childminder provides varied learning opportunities across all seven areas of learning. Children are making good progress from their starting points. Since the last inspection, the childminder has reviewed how she plans and monitors children's progress. The childminder regularly reviews the service she provides and seeks the views of parents and children as part of her evaluation.

## Quality of teaching, learning and assessment is good

The childminder has high expectations for the children. She completes a summary of children's learning each month and celebrates their significant achievements. The childminder places a strong emphasis on developing children's communication skills. Younger children make sounds and begin to use single words or two words together. The childminder repeats their words back to them and maintains good eye contact to make sure children are listening. Children who are more skilled at conversation are encouraged to recall events. They talk about family birthdays and eagerly describe the cake. The childminder plans opportunities to support physical development and exploration. Children explore a dry and crunchy textured material. They skilfully use spoons and containers to move and explore what they can do with it. The children are supported to be active learners as they take off their socks to explore with more parts of their body. The childminder is fostering children's love of books and songs which helps to support their early reading skills.

## Personal development, behaviour and welfare are good

Children are happy and demonstrate a strong sense of belonging within a caring and welcoming environment. There are a variety of accessible resources for the children. The childminder is skilled at giving children time to independently explore resources. Children receive lots of praise, encouragement and support for their achievements. The childminder gives children opportunities to help and share responsibility for small tasks. For example, children carefully carry healthy snacks from the kitchen to the playroom. This helps to support their self-care and independence skills. Children have ample opportunities to develop their physical skills. The childminder reminds children about keeping themselves safe and maintains a safe and secure environment for them to play in.

### **Outcomes for children are good**

All children are making good progress in their learning from their starting points. Children's communication skills are developing well. They are eager to learn and show high levels of concentration during activities. Children are prepared well for their next stage in learning, such as school.
