- The childminder values working together with parents and other professionals to provide continuity of learning and care for children.
- The childminder believes in helping children to be considerate to others and to behave well.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation.
