Summary of key findings for parents

This provision is outstanding

- The childminder has very clear and consistent boundaries in place, which help to promote children's understanding and they behave exceptionally well.
- The childminder and her assistant attend very regular training to enhance their already excellent knowledge. This helps them to provide excellent quality care and learning.
- The childminder provides extremely high-quality teaching, helping to enable children to make excellent progress with their learning and development.
- The childminder gathers parents' views on a regularly basis. She uses these exceptionally well to continually drive her excellent practice.
- The childminder has an excellent understanding of children's individual needs. This helps the childminder to plan exceptionally high-quality activities that promote their learning and development extremely well.
- Children have a very strong bond with the childminder and her assistant. This helps to settle them in very quickly, ready to start their excellent learning experiences.
- Leadership and management of the provision is extremely strong. The childminder carries out regular review meetings with her assistant. These are of a high quality and help the childminder to identify strong practice and any areas to work on.

Inspection findings

Effectiveness of the leadership and management is outstanding

Safeguarding is effective. The childminder has an excellent understanding of child protection procedures and how to safeguard children. For example, she carries out highly detailed risk assessments, which enable children to play in a very safe learning environment. She practises regular high-quality fire drills, which further enhance the excellent safety of the children. The childminder works very closely in partnership with the local early years team. They work extremely well to promote all aspects of the childminder's excellent practice and target areas to strengthen. The childminder also has excellent partnerships with other professionals caring for the children. This helps to provide excellent continuity of care for children.

Quality of teaching, learning and assessment is outstanding

The childminder completes high-quality assessments, enabling her to review the excellent progress children make. She monitors and tracks children's development and is able to narrow any gaps in their achievement very quickly. This helps to promote the extremely high-quality care the childminder provides even further. For example, the childminder highlighted the children's keen interests in books. She has adapted and extended book areas within her home and has clearly identify further activities to strengthen even more children's learning. The childminder works extremely well with parents. For example, she undertakes regular parents' evenings. They share the excellent progress children make and their future learning plans. Parents also share what children are doing at home, which further strengthens the childminder's assessments of children's progress.

Personal development, behaviour and welfare are outstanding

The childminder promotes children's health and well-being extremely well. For instance, they have excellent access to resources to promote their physical development. Children's independence skills are highly nurtured through all aspects of play. Children thoroughly enjoy extremely healthy snacks and meals, and high-quality teaching helps them to learn about healthy lifestyles. However, this is slightly less evident during some cooking activities. Children are extremely confident learners and are more than happy to ask for different activities to undertake. The childminder is also highly skilled in changing and adapting her planned activities for the younger children, to meet their individual needs and to enable them to join in. This builds on children's self-esteem and confidence extremely well.

Outcomes for children are outstanding

Children make excellent progress with their learning and development from their original starting points. They are more than ready for their next step in learning and subsequent move to school.
