Summary of key findings for parents

The provision meets requirements

- The childminder meets the safeguarding and welfare requirements. She knows her legal obligations on providing information to Ofsted, to keep children safe and to protect them from harm. She undertakes safeguarding training to keep up to date.
- The childminder understands the importance of managing children's behaviour consistently, and of teaching children to listen to the views of others to promote children's personal development.
- The childminder understands how to plan to meet children's individual learning and development needs whatever their abilities, ages and backgrounds. She knows the need to assess children's progress at age two years, and to help children to be ready for school.
- The childminder realises the importance of carrying out regular risk assessments so children can play in a safe environment.
- The childminder understands the need to reflect on her practice and highlight any training needs to improve her provision.
- The childminder understands the importance of working with other professionals and with parents to know and meet children's needs, including their physical needs.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

- The inspector looked at the areas used for minding.
- The inspector spoke with the childminder regarding her knowledge of requirements.
- The inspector sampled documents, including the first-aid qualification and risk assessments.
- The inspector viewed the range of resources available for children's play.

The childminder started in 1988 and registered with Ofsted in 2001. She lives in Putney Heath in the London borough of Wandsworth. The childminder works all year round. There were no early years children on roll at the time of the inspection.
