Summary of key findings for parents

This provision is outstanding

- The childminder and her assistant provide an excellent service for parents and outstanding outcomes for children. They use their systems of self-evaluation highly effectively to continue to drive improvement.
- The childminder provides a stimulating, welcoming environment where children are eager to explore and learn. Excellent activities and teaching help all children to make rapid progress. The childminder has very high expectations of what the children can achieve and is highly responsive to children's interests each day.
- The childminder works extremely well in partnerships with parents and other early years providers. Settling-in procedures are individual to each family and child's needs. This has a highly positive effect on children's well-being, ensuring they feel secure and confident.
- The childminder and her assistant work exceptionally well together and have an impressive knowledge of how children learn. They deploy themselves extremely effectively to protect and promote children's welfare and support their learning.
- Children are extremely independent and self-motivated. The childminder is skilful in responding to children's interests. Children concentrate on tasks and spend time practising new skills and working out how to use the resources in their own way.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

help children to learn even more about the natural world.

- The inspector observed activities and the quality of teaching, indoors and outdoors.
- The inspector spoke with the childminder and her assistant at convenient times and carried out a joint observation with the childminder.
- The inspector checked safeguarding information and the premises.
- The inspector took account of the childminder's self-evaluation and parents' written feedback left for the inspection.
- The inspector sampled documentation, including policies and procedures, children's development records and planning.

Inspection findings

Effectiveness of the leadership and management is outstanding

Safeguarding is effective. The qualified childminder and her assistant have an excellent knowledge of their responsibilities. They attend regular and extensive safeguarding training. They know what to do should a child be at risk of harm, and implement highly effective procedures. The childminder uses training extremely well. For example, through knowing how best to support and guide her assistant effectively, children receive high quality teaching at all times. The childminder has an exceptional awareness of supporting the whole family to ensure the best outcomes for children. She keeps excellent records to help her monitor children's development and ensure they all reach their full potential.

Quality of teaching, learning and assessment is outstanding

Following her last inspection, the childminder has reviewed and improved her assessment systems. She now seeks even more extensive information on children's starting points and sends her initial observations home for parents to comment on. This enables her to skilfully plan for children's learning from the beginning. The childminder and her assistant use highly successful teaching skills and focus on children's interests to motivate them to learn. Young children learn letters and how things change through exciting activities, such as when following a trail in the garden and mixing water and cornflour, for example. They learn shapes and numbers as they play and develop their early reading and writing skills. Children enjoy being outdoors and going on outings. However, the childminder misses occasional opportunities to help children learn even more about the natural world.

Personal development, behaviour and welfare are outstanding

The childminder and her assistant have a thorough understanding of each child's individual needs and meet their physical and emotional needs extremely well. Parents state that the childminder used excellent practices to help their children to settle by getting to know them really well and building strong emotional bonds. The childminder organises her environment extremely well and provides children with an excellent range of resources. Children's behaviour is exemplary. They listen to others' opinions and value their views. Children develop an excellent awareness of keeping safe and healthy through exciting activities. For example, children made books about healthy eating, and young children learnt to use tools safely at the table.

Outcomes for children are outstanding

The childminder provides excellent support so that all children make outstanding progress. They thoroughly enjoy their learning and gain excellent skills that prepare them exceptionally well for school.
